Theola Patterson v. Theresa Wright-Reid  
Case No: 2022-000667

This is to serve as a petition request to reinstate the Appeal attached to the case number above.

Due to the passing of my father, on February 13, 2022, I am informing the courts that Theophilus Wright, has listed ALL of his children on his last Will in Testament including myself, Theola D. Patterson (Wright). I was residing in Daddy's home from January 2018 until July 20, 2022. I am now homeless due to my eviction on July 20, 2022. I was not granted the emergency stay by your court and therefore the eviction took place on the above date. I have since changed my phone number and I continue to use the above address, although my siblings filed a "no trespass" order against me, because #1) I do not want them to know where my temporary address is because of their hate for me, #2) I do not want to put anyone else through the harassment that they bring with their messiness, and #3) I own 1/6<sup>th</sup> of my father's home no matter what the other 5 children of my parents do with Dad's properties behind my back. If there is a need for communication with my father's other children, they have my email address.

Upon my father's death, and since the estate has been filed in Probate court (March 18, 2022), this matter should be completed in Probate Court. The parties on this "notice to quit" order has changed from the initial proceedings and the Power of Attorney is no longer valid. I have now filed a "claims and delivery" case in the Magistrate court in Goose Creek because Theresa Wright-Reid (former Power of Attorney) will not give me my belongings from my father's home.

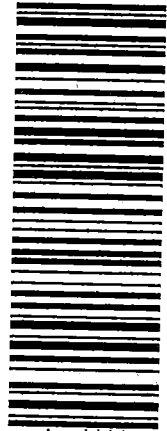
All evidence and hearings should be investigated thoroughly, including the video that was heard by the Magistrate Court (in which the initial decision was made to evict), which was not heard by one that was in the Mental Health profession. The Magistrate nor their attorney had never met my father and obviously he had been coerced into making certain statements on camera. Even while being coerced Dad made statements that were cohesive to his character and his love for ALL of his children. Prior to that video, the magistrate instructed Theresa Wright-Reid that she would need to bring in a mental health professional to assess my father's mental state if he were to appear in court. By the hearing and seeing of my father via video, this should be considered an appearance in court just as any zoom meetings that are permitted.

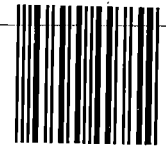
