JOINT CONSENT MOTION FOR EXTENSION OF TIME

Respondent, Palmetto Industrial Development, LLC, by and through its undersigned counsel, hereby requests an extension of time of ten (10) days to file its Return to Petitioner’s, The Gulfstream Café, Inc., Petition for Writ of Certiorari. 
Neither Respondent not Petitioner have previously requested, or been granted, an extension for any purpose.


