The Respondent, Interinsurance Exchange of the Automobile Club (“Respondent AAA”) moves that it be dismissed from the Appeal in this matter.

The basis for the Motion is that on September 19, 2018 the lower court granted the moving Respondent’s Motion to Dismiss it from the cases then pending in the Court of Common Pleas for Chester County. From that Order this Appellant appealed. On May 14, 2019, this Court entered its Order dismissing the appeal.

The Appellant filed a Motion to Reinstate or to rehear the dismissal of this appeal. On July 20, 2019, this court entered its Order denying the Appellant’s motion to reinstate or to rehear. The Appellant then filed a Petition for Writ of Certiorari on September 24, 2019. On April 24, 2020, the Supreme Court of South Carolina filed an Order denying the Appellant’s Petition for Writ of Certiorari and on June 23, 2020, the Court entered a Remittitur to the Circuit Court of Chester County.

As a result, your moving Respondent has not been a party to this case since it was dismissed in 2018.




