TAMARQUE'S ANTIWAN WINGATE, THE PETITIONER, HONESTLY AVOU, THAT (HE) IS AN 'ACTUALLY INNOCENT UNQUESTIONABLY HUMAN BEING; AND THAT HE WAS BORN IN THE UNITED STATES, IN THIS GREAT STATE OF SOUTH CAROLINA, WHO WAS WRONGFULLY AND VERY PRESUDICIALLY CONVICTED.

IN THIS MATTER(S) AT THIS VERY MOMENT, OF THIS ~~FILE~~, A TRANSCRIPT IS NOT SO REQUIRED. THE POST-CONVICTION COUNSEL FAILED TO INVESTIGATE THE INEFFECTIVE ASSISTANCE FROM PETITIONER'S ATTORNEY AT TRIAL. COUNSELS IN FULL DID ENGAGED THEMSELVES IN A PATTERN THATS CONSISTENT WITH MISCONDUCT, INCLUDING THE FAILURE TO ACT WITH SOME/ANY REASONABLE DILIGENCE AND PROMPTNESS IN REPRESENTING WINGATE, AND THE FAILURE TO REASONABLY COMMUNICATE.

EVIDENTIARY DEVELOPMENTS SHALL BE ORDERED, ON THE GROUNDS THAT THE POST-CONVICTION COUNSEL IS NOW ALLEGED BY THE PETITIONER, THAT (COUNSEL) HAVE NEGLIGENTLY FAILED TO DEVELOP THE STATE COURT RECORD. THE GUILTY VERDICT NEEDS TO BE CHALLENGED; (IT'S INSUFFICIENT).
