Additional Information for the Clerk:

This matter comes before the Court to determine the final amount of pre-judgment interest owed to Plaintiff Hess. In Plaintiff's Petition, Plaintiff originally sought pre-judgment interest in the amount of \$380,950.95. This amount was calculated through February 14, 2022, the date of Plaintiff's Petition based on the jury's verdict.

To take into consideration the additional days from the date of Plaintiff's Petition through the date of entry of the Order granting Plaintiff treble damages, attorney's fees, and pre-judgment interest entered on November 2, 2022, the Court ordered Plaintiff's counsel to calculate and provide to the Court the additional amount of pre-judgment interest for those days. Based on Plaintiff's calculations, factoring in the settlement with the CPA firm, an additional amount of \$26,070.10 has accrued. This amount is broken down as \$4,600.38 through March 21, 2022 and \$21,469.72 after March 21, 2022 and through November 2, 2022. This rate was calculated using the statutory rate of 8.75% for pre-judgment interest.

Therefore, pre-judgment interest in the total amount of \$407,021.05 is, hereby, awarded to Plaintiff Hess.
