The respondent respectfully moves the Court for a further 3-day extension of time in, which to file a petition for rehearing. As grounds for the motion, the respondent would show:


1. The Court generously granted a needed fifteen day extension of time for the respondent's petition for rehearing. The petition is now due on Friday, October 28, 2022.



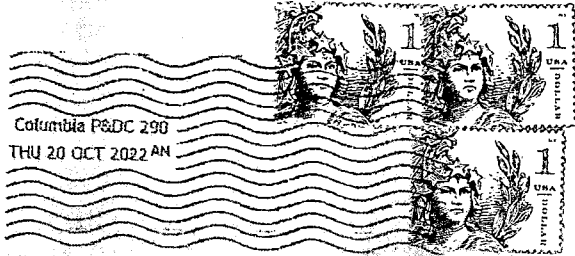
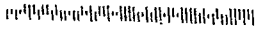
