Ms. Howard:

In response to the below email, I would like to offer the Court some information on the above-referenced appeal and appellant.

As noted in the appeal, our Municipal Judge Brian Jefferies denied Mr. Daniel's motion to dismiss. Prior to a scheduled trial which was set to be held, I verbally requested a motion *in limine* to request the defendant to not bring up issues of law during his trial. After the judge granted my motion, the defendant requested a court-appointed attorney. The request was granted and the trial was continued until Mr. Daniels could meet with the court-appointed attorney Mr. Harry Hancock, who is currently handling the above-referenced tickets.

I would submit that Mr. Daniels' appeal appears to be clearly interlocutory in nature, and would also ask as to whether Mr. Daniels can file motions individually when he is represented by counsel.

I appreciate any guidance the Court can offer in this situation.
