I would also like to ask you, can you please send a request to SLED to ask them to do a criminal investigation due to the criminal misconduct that has been committed against me in this case against me by the Greenwood Co. Prosecutor Micah Black, Ass. Att. Gen: Brianna Schill, trial lawyer Jane Merrill, Appellate Defense Taylor Gilliam, PCR Lawyer - Ashley McMahahan and my writ of cert. lawyer Scarlett Moore.
