**NOTICE OF SCRIVENER’S ERROR IN RETURN IN OPPOSITION TO
MOTION FOR LEAVE TO FILE *AMICUS CURIAE* BRIEF**

Respondent Herman Perry Holcomb (“Holcomb”) hereby gives notice of scrivener’s error in his Return in Opposition to Motion for Leave to File *Amicus Curiae* Brief (“Return”) as follows:

On page 2, immediately following the roman numeral I. header the Return states,

Holcomb filed the underlying matter on May 24, 2019, three and a half (3 and 1/2) years ago. On August 16, 2019, the matter was decided in Holcomb's favor and he was awarded his reasonable attorney's fees.

This sentence should be replaced with,
