
APPELLANT'S REPLY TO RESPONDENT'S OPPOSITION

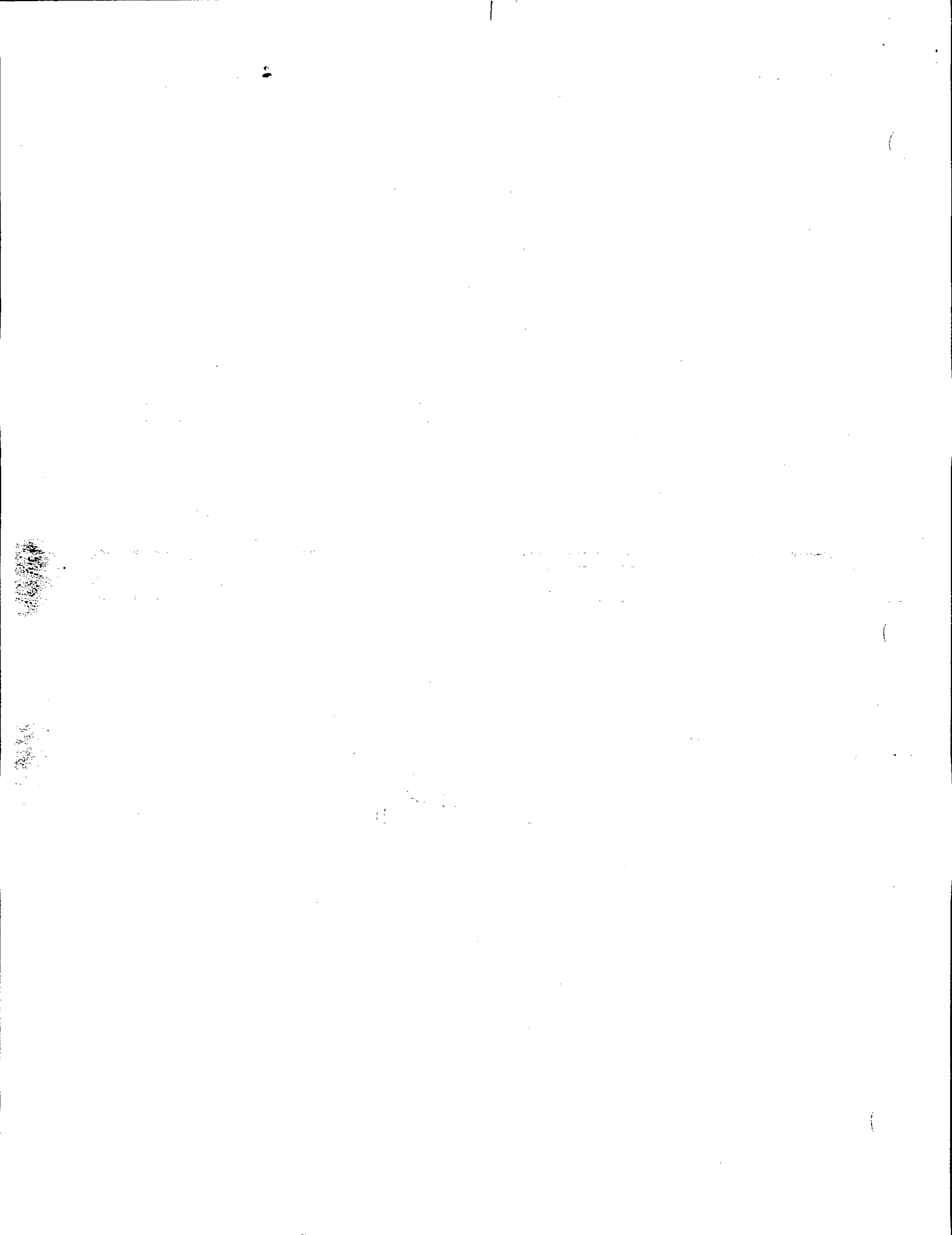


