I am writing to inform the Court that the parties have agreed to settle this matter following a two-day mediation on November 17<sup>th</sup> and 18<sup>th</sup>, and continued negotiations last week. While the exact terms of the settlement agreement are still being finalized, an agreement has been reached pending approval by the circuit court.

Because of this settlement Respondent will not file an Initial Brief, which is due November 30, 2022. I have conferred with Appellant's counsel regarding the Initial Brief, along with my intent to notify the Court by way of this correspondence. Recognizing this Court's need to be kept updated, I plan to send two update letters: (1) when the agreement is finalized and (2) when the circuit court schedules a hearing.
