MOTION FOR AN EXTENSION OF TIME TO
SERVE AND FILE THE PETITION FOR WRIT OF CERTIORARI

Counsel for petitioner respectfully requests an extension of thirty (30) days in which to serve and file the Petition for Writ of Certiorari and Appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The Petition for Writ of Certiorari and Appendix are due to be served and filed with the Court today.
2. Counsel for petitioner respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions


previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Frankie Davis with the Court of Appeals on October 13, 2022. Counsel filed the petition for writ of certiorari in the case of Breon J. Mayers v. State with the Supreme Court on October 12, 2022. Counsel filed the Anders brief of appellant in the case of State v. Christopher Lee Briggs with the Court of Appeals on October 12, 2022. Counsel filed the Anders brief of appellant pursuant to White v. State in the case of Michael Boykin v. State with the Court of Appeals on October 6, 2022. From September 19, 2022 through September 21, 2022, counsel attended the Annual Public Defender Conference in Myrtle Beach. Counsel filed the Anders brief of appellant in the case of State v. Cedrick Gaines with the Court of Appeals on September 16, 2022. Counsel filed the brief of petitioner in the case of Jalen T. Badger v. State with the court of Appeals on September 12, 2022. Counsel filed the petition for rehearing in the case of State v. Derrick Miles with the Court of Appeals on August 25, 2022.


4. Counsel makes this request in good faith and not for purpose of delay.
