APPRECIATED.

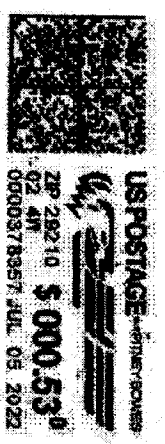
