Motion For Reinstatement

For good cause, pursuant to South Carolina Appellate Court Rules 204, 221(b) and 260 (a), Appellant requests that this appeal be reinstated and transferred back to the South Carolina Supreme Court so that the appeal can be heard by the court of proper statutory jurisdiction, and that no remittitur to the lower court shall issue from this court.

Due to inadvertence or mistake, this appeal was transferred to the S.C. Court Of Appeals and subsequently dismissed by this court's clerk due to this court having no jurisdiction. However, this appeal was made to the South Carolina Supreme Court, under that Court's appellate authority given at S.C. Code 14-3-330 (2)(a), to review orders affecting substantial rights, and this appeal meets all of the additional requirements of that statute.

The S.C. Court of Appeals would not and could not ever have jurisdiction over appeals made under S.C. Code 14-3-330 (2)(a), and the S.C. Supreme Court Clerk's transfer of this appeal to the S.C. Court Of Appeals effectively amounts to a dismissal of the appeal. Such a "dismissal" violates Appellant's right to due process of law, and will undoubtedly result in another appeal and further litigation. Any dismissal of this appeal should come by order of the S.C. Supreme Court, not by way of a dismissal by the S.C. Court Of Appeals after the case was inadvertently or mistakenly transferred to this court.

Additionally, the court please note that Appellant never received notice of the order transferring the appeal to this court, but rather, was first alerted to the transfer by receipt of this court's order of dismissal.

For the above reasons, Appellant respectfully requests that this appeal be reinstated by the S.C. Court Of Appeals and transferred back to the S.C. Supreme Court to be reviewed as is statutorily proper, and that no remittitur should issue to the trial court from this court.
