
MOTION FOR ADMISSION *PRO HAC VICE* OF JONATHAN Y. ELLIS

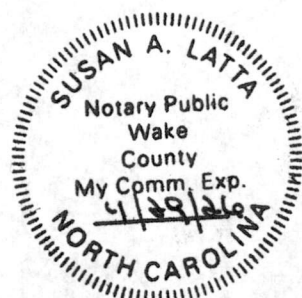
