**MOTION FOR EXTENSION OF TIME
 TO FILE
 MOTION FOR RECONSIDERATION FOR A FEE WAIVER**

NOW COMES, the Appellant, Regina M. Hunter El, to request a 21-day extension of time to file a Motion for Reconsideration for a fee waiver and states the following in support of:

- On 23 September 2002, the Appellant filed her initial Notice of Appeal pursuant to SCACR Rule 262.
- On 7 October 2022, the Appellant filed an amended notice of appeal and motion for a fee waiver with proof of service to correct deficiencies indicated by the Clerk of Court on the 27 September 2022. The opposing party did not file a return to the said motion.
- On 22 November 2022, the Court denied the Appellant’s Motion for a Fee Waiver pursuant to *Ex parte Martin v. the State* 321 S.C. 533, 471 S.E.2d 134 decided by the South Carolina Supreme Court 5 May 1995, 27 years ago.
- The Court ordered the Appellant to pay the filing fee within 15 days of its order or by 7 December 2022.
- Between 23 September—October 2, 2022 Hurricane Ian made landfall on the coast of South Carolina with as a category 1 storm with 85 mph winds. Though downgraded to a tropical storm, the Appellant was still adversely impacted by the storm in the midlands because a large volume of her personal property was stormed outdoors under large tarps and/or plastic sheeting.

- At the time of the storm’s landfall, the Appellant was still in the process of sorting and discarding damaged goods from her former ejection. This storm’s winds exacerbated damage and complicated her efforts to complete the organization and removal tasks. After the storm, the Appellant increased time spent to organize, clear, discard, recover and repackage salvageable items to a more secure location. This urgent need reduced the amount of time the Appellant was able to devote to legal research.
- In addition, the Appellant asks the Court for additional time to file her Motion for Reconsideration for a fee waiver to research case precedents using legal research tools which require her to pivot to public facilities while providing intermittently elderly care.
