NOTICE OF APPEAL

Appellant James John Todd Kincannon respectfully appeals the portions of the Order entered December 13, 2019 which adjudicate the causes of action asserted by Appellant—Plaintiff below—against Respondent—Defendant below—in the Complaint in Kincannon v. Griffith, Civil Case No. 2019-CP-32-2268.
