MOTION FOR PERMISSION
TO FILE FUTURE ACTIONS

Petitioner now requests permission to file further collateral actions in the circuit court, challenging his 2006 convictions and sentences.

Petitioner is stating that he has only filed 4 post-conviction relief actions challenging his conviction, and it would be discriminative for the Court not to allow him to further challenge when others were allowed to file 64 actions, deemed frivolous before being restricted. See In re Theron MAXTON, 325 S.C. 3, 478 S.E. 2d 679 (1996).


I, Jabbar Jomo Straws, being duly sworn make the following statement:

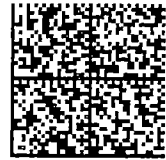

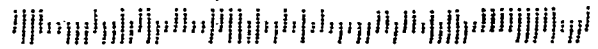
