

Pursuant to Rule 260(b) of the South Carolina Appellate Court Rules, Appellant QBE Insurance Corporation, as assignee of P.V., Inc. d/b/a Harbor Inn, and Respondents William Fincher, Harrison, Fincher & Associates, LLC, and Harrison, Fincher & Associates, Inc. agree to a dismissal of the Appeal in its entirety for the following reasons:

1. QBE Insurance Corporation has fully paid and satisfied the judgment incurred by P.V., Inc. d/b/a Harbor Inn from the underlying case of *Leola Richardson as Personal Representative of the Estate of Dominick Richardson v. P.V., Inc. and Harbor Inn, Inc.*, Case No. 2005-CP-22-357, thus P.V., Inc. has no claim for damages against Respondents in this action.




