




Dear Sir or Madam;

I thank you for your time and attention to this matter.

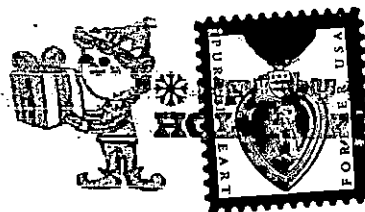
