MOTION FOR
APPOINTMENT OF COUNSEL

I, James Millholland, pro-se, Appellant in the above captioned matter respectfully request that this Court appoint an attorney to litigate this case on my behalf based on the following:

1. The S.C. Court of Appeals reversed and remanded this case once already and the Remittitur was sent down to the Administrative Law Court on Aug. 4, 2022. The ALC was ordered to hold a hearing on the

merrits of this case to determine what process the Appellant was entitled to but refused to do so. Instead of obeying this order from the higher court, the ALC only rubber stamped a second Order of Dismissal and yet again denied the Appellant his right to due process

2. Appellant is an indigent inmate in the South Carolina Department of Corrections and is without the funds to obtain proper representation.
3. Appellant is without training in matters pertaining to law, litigation, court procedures, and especially appellate rules
4. Appellant does not know how to force S.L.E.D. to turn over the documentation pertaining to the suitable sample of DNA and the \$250 dollar processing fee that was collected in the years 2000-2004 while serving a sentence of five years for burglary in Anderson County. And this piece of information is vital to proving the whole case.
5. Appellant will be completing this sentence in S.C.D.C. on June 1st, 2023 (5 months) and will be living homeless without an address to receive any mail.
6. Appointment of Counsel is crucial in this case to make sure the Appellants constitutional rights are

properly protected.

WHEREFORE,

The Appellant prays this Honorable Court will appoint him counsel and for all other relief this Court deems just and proper.

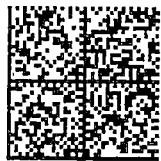

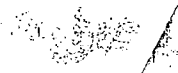
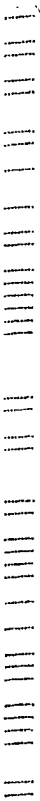
