1. I am requesting a Motion for Final Brief Extension and in my previous motion I requested ("to get the ASCII Disks (unedited rough copy) and Unedited (rough draft) emailed transcripts") on October 22, 2022, for which I did not receive a response in the mail until December 15, 2022, stating that I have 30 days from this date to respond. Given that this is the holiday season, I am requesting additional time to submit the final brief.
 - a. In the previous motion, I also requested that the Court of Administration preserve my transcripts and records. To my understanding, the Statute of Limitations allows for records to be purged after 2 years, during which this case will still be ongoing.
2. I have continuously complained via email and in my Record on Appeal that the transcript from the August 23 and 24, 2021 trial had been altered. The transcript originally came in two parts where the second half (page 336) of the transcript that was provided on December 5, 2021 was not signed (attached) and cannot be certified. I now see in my email a new copy of the transcript received in November 2022 where the second half is now signed (attached). It is illegal for a document to be altered after being submitted to

the Court of Appeals, which is falsifying documents. For this reason, my Final Brief cannot depend on the court transcript because it has been altered by the Respondent. Again, I am requesting that I am allowed to have the unedited transcript, audio recording, and a copy of the WebEx video hearing which I have already submitted a subpoena for and am pending a response.

Please address these concerns in a timely manner due to the upcoming Final Brief deadline. I will submit a \$50.00 payment to file this motion.



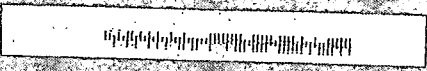
