
Dear Ms. Allen and/or Renee':

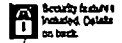

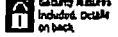
