Counsel filed the Petition for Writ of Certiorari and Appendix in the case of Samuel Jeter v. The State with this Court on January 6, 2023. Counsel filed the Petition for Certiorari to the Court of Appeals and the Appendix in the case of The State v. Amy N. Taylor with this Court on December 6, 2022. Counsel filed the Petition for Writ of Certiorari and the Appendix in the case of Toaby Alexander Trapp v. The State with this Court on November 18, 2022. Counsel filed the Final Brief of Appellant and Record on Appeal in the case of Michael A. Williams v. The State with the Court of Appeals on November 9, 2022.


4. Counsel makes this request in good faith and not for purpose of delay.


