





all nine (9) of their children; six (6) now deceased. The three (3) remaining want to sell the property.



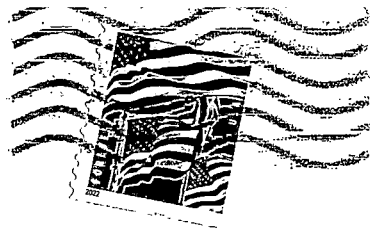
