of first filing a complaint within

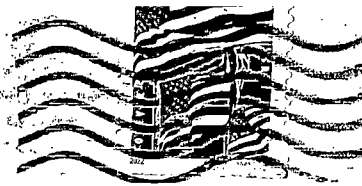
