
MOTION TO REINSTATE APPELLANT'S CASE ON APPEAL



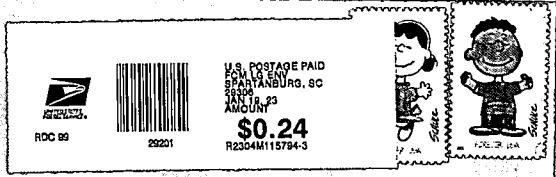
