Dear Ms. Kitchings and Ms. Allen:

Appellant-Respondent Rigdon H. Boykin and Respondent-Appellants Mary Deas Wortley and Alice B. Belger have reached an agreement on the terms of a full and final settlement between them. I represent Mr. Boykin, and James Y. Becker represents Ms. Wortley and Ms. Belger.

We will be filing an agreement for dismissal of our respective appeal and cross-appeal pursuant to SCACR 260(b) as soon as the settlement paperwork has been finalized. Because this case has been set for oral argument on February 9 at 11:20, we jointly and respectfully request that the oral argument be cancelled pending dismissal of the appeal and cross-appeal. We will work to complete the paperwork and submit the agreement for dismissal as quickly as possible.

Please note that this settlement does not resolve the Respondent-Appellants' cross-appeal of the attorney's fee award to Lemuel Whitaker Boykin, III, and May Cantey Boykin, who are represented by William S. Tetterton. These parties and that cross-appeal were not included in the upcoming oral argument, and therefore that aspect of the appeal should not affect our request to cancel oral argument pending submission of an agreement for dismissal.


