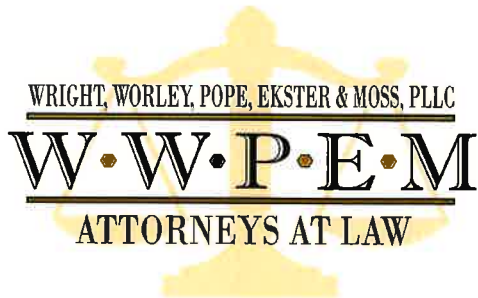

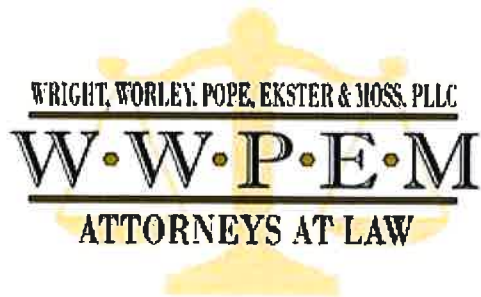
Good afternoon,
