**MOTION FOR EXTENSION OF TIME
TO PAY FILING FEE**


NOW COMES, the Appellant, Regina M. Hunter El, to request a 35-day extension of time to file a pay the required filing fee and states the following in support of:

- The petitioner’s finances were adversely impacted by her ejection from her property more than a year ago after a false application was made accusing her of criminal trespass. The security, salvage and recovery of personal property belonging to her and her elderly father persist. Thus, such extension is necessary to ensure the petitioner’s right to appeal the decisions of the lower trial court is not denied simply due to financial constraints.
- On 8 December 2021, a judgment was entered in the amount of \$1,898.10 plus court costs in favor of Crown Assets Management, LLC who acquired a debt from Synchrony Bank under a Wal-Mart® Credit Card Agreement. Due to the deliberate lack of notice of the hearing by the summary court and improper service, the Defendant was denied the opportunity to appear or enter her counterclaims in person.

- On 27 May 2022, the Appellant contacted Wal-Mart Store, Inc. Legal Department regarding three unresolved claims. On 9 June 2022, Melissa Price, Wal-Mart's General Liability Case Manager responded to address the slip and fall claim only (Claim # 9629356 and/or Claim #L1597885) that occurred on 21 April 2021. Price offered a full and final settlement in the amount of \$750.00 but the Appellant rejected the offer due to insufficient consideration for medical care, pain and suffering and other general/special damages. In addition, Price stated another department or persons would address the other claims, but no response is forthcoming thus far. Thus, this extension may also aid in learning of any further response from the Wal-Mart legal department on other outstanding claims
- This extension is not meant to cause delay and burden upon the opposing party.

Therefore, the petitioner asks the Court to grant her until on or about 21 January 2023 to pay the required \$250.00 filing fee.



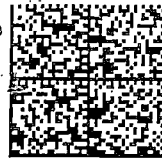
