MY REINSTATED SENTENCE HAS EXCEEDED THE MAXIMUM AUTHORIZED BY LAW BECAUSE SCDC DID NOT PROPERLY ~~FOR~~ APPLY MY TIME SERVED CREDIT. S.C. STATUTE 24-13-40 PROVIDES THAT I'M ENTITLED TO MY TIME SERVED CREDIT OF 422 DAYS. SCDC DECISION IS IN VIOLATION OF CONSTITUTIONAL OR STATUTORY PROVISIONS; IN EXCESS OF THE STATUTORY AUTHORITY OF THE AGENCY; MADE UPON UNLAWFUL PROCEDURE; AFFECTED BY OTHER ERROR OF LAW; CLEARLY ERRONEOUS IN VIEW OF THE RELIABLE, PROBATIVE, AND SUBSTANTIAL EVIDENCE ON THE WHOLE RECORD; OR ARBITRARY OR CAPRICIOUS OR CHARACTERIZED BY ABUSE OF DISCRETION OR CLEARLY UNWARRANTED EXERCISE OF DISCRETION.
