In response to your letter of January 19, 2023, I have submitted the filing fee of \$50.00 to your office. As enclosed proof of service indicates, I am in compliance with the SC Appellate Court Rules. As I am sure you are aware, there is no requirement that Appellant Pro Se slavishly copy every detail of Form 7. To the contrary, the Appendix "contains forms which MAY be used for Rules 201-241, SCACR. These forms are in the nature of examples which can be MODIFIED to meet the needs of a particular case." (Emphasis supplied.) The use of these forms is recommended, but not required. Pro Se Appellant's appeal as of right is constitutionally guaranteed to be heard on its merits, and every court in South Carolina has a duty to conduct themselves in such a manner as to do substantial justice. A clerk may not deliberately exalt form over substance so as to attempt interference with a constitutionally guaranteed right of appeal. Appellant has submitted the requisite fees, correctly served Dominion's attorney by certified mail, and submitted a proper Proof of Service to the Court. Appellant's Proof of Service DOES state that a copy of the motion to reinstate was served on respondent Dominion's counsel. There should be no further interference with Appellant's rights of due process by the court itself. Thank you for your attention to this matter.



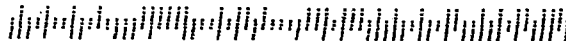

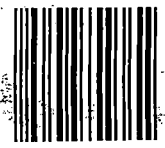
