only issues before the Court of Appeals regard insurance coverage and which entity, the UEF or the Guaranty Association, may potentially be the responsible carrier for the underlying claims. The potential liability of the ultimate carrier in the instant case to the individual claimants has not been determined by the South Carolina Workers' Compensation Commission. Further, the merits of each individual workers' compensation claim have not been determined and will be decided upon remand to the South Carolina Workers' Compensation Commission.

Moreover, the individual claimants and their attorneys have been excused from participation in this matter thus far by the Commission, and did not participate at the Circuit Court level. Accordingly, inasmuch as this case does not affect any rights of my client directly, I do not plan on filing any pleadings on behalf of Mr. Steven Cameron, nor do I plan to appear at oral argument.


