Randy, I am firing you from representing me on my case with American Express and Switzer.

I feel that you never believed me when I told you that I did not owe American Express any money and you would always look at me and tell me that I did owe them. I have proof now that they never returned the \$5535⁰⁰ that I sent them and did not owe them. The three times that I came to your office I felt threatened by you. You would look at me and say stop it when I tried to explain to you something on my records and then you told me to say that I would settle with them for \$3,000⁰⁰ or how much would I settle for and I told you I would not settle for any money I didn't owe.

Then you would say yes you do owe
it and I know that I don't.
 The three times that I went to your
 office and talked to you you mad me
 feel scared. I am 80 years old and
 due ^{to} this last 7 months I have developed
 alzheimers disease. I have a letter from
 doctor, I did not need to be under so
 much stress the three times that I went
 to spent an hour talking to you.
 And you were very ugly and rude to me.
 You should have talked about those papers
 with me and not tell me over and over again
 that I owed this. The statements are all
 Switzer gave to me as proof I owed and not
^{attorneys}
on any statement did it ever itemize how
much they said I owed. You should have
 talked to them and told them to show
 the amounts I owed but you said that
 you never talked to them or their lawyer
 instead of telling me I owed I closed
 all accts I ^{had} with them on January 2020
 and never made any purchases on any
 cards with them after ~~January~~ December 2020

On January 2021 American Express sold
 Sutzger Associates New York, to American
 Express created a new account for me
 and my old card number was 98006 I had
 a zero balance and on January 2021 they
 gave me a new number of 86006 and
 transferred a new balance to that card
 and never sent me a new card. I never
 made a charge on this card new activated
 or never seen it and told me on phone
 that I owed \$5535⁰⁰ I sent them a check
 from Bank of America and on January 15 2021
 I stopped payment because I saw where
 they put a balance I did not owe. I told
 them to send me my check back for the
 \$5535⁰⁰ but they never did so that is
 where the money is. They put on my January 21
 statement but it said reversed on my
 statement of the \$5535⁰⁰ but I did ^{not} receive
 it back nor did my bank ever get it back.
 They sold the acct to Sutzger Associates
 in New York in 2022 and they know nothing
 about how to find my ^{corrected} ~~corrected~~ on the account
 and Bank of America says that Sutzger has
 to send the paperwork so that means neither

American Express nor Switzer can correct
and find that I owe nothing when
Switzer and Associate brought this act
I called American Express and they said
that they sold it to Switzer and Switzer was
the one who would get the money and
that's why they would push me to give
it to them that is what they do
is buy acts and see how much they
can make, but I do not owe any
on ~~no statement~~ there is not one statement

that says I owe any money I spent
every month they have interest and fees
totaling \$1180 month and sometimes more
my lawyer would never talk to me about this.
He said I will see how much they will
let you settle for, and American Express
said it not up to them it's how much
their lawyer William Stark with Switzer and
my lawyer would settle for so American Express

said they had nothing else to do with this
Also on the day my judgment was I went to
court and sat there I can not see very good
so I could not see the screen in the
courtroom in Daffrey but I went to the
front and I heard a man say we want to

Bump up this case so someone said
Oh we will bump it up, I thought that
ment continued so I sat down and
then left. never heard nothing at all that
day from my lawyer. Randy Skinner
next day I called courthouse to ask when
my case we heard. She said they
heard it after you left, I was
shocked. why didn't my lawyer
tell me don't leave Miss Hutchins we
will hear it later. And he never
called me after that I called him a
few weeks later and talked to him.
He did not tell me until I asked him
that they heard it after I left. Due to me
mental conditions and heart problems. I feel
that he should have tried to help
instead of treat me the way he did I paid
him \$2,500 and seen him in his office
3 times around 1 hour each time So I am
