Counsel for appellant respectfully requests a thirty (30) day extension, in which to serve and file the Initial Brief of Appellant and Designation of Matter in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a third request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed today.

2. Counsel will be attending the American Bar Association Midyear Meeting in New Orleans from February 2-5, 2023. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Antly Jermaine Scott with the Court of Appeals on February 1,

2023. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Tammy G. Harris v. State with the Supreme Court on January 25, 2023. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Perez Brooks v. State with the Supreme Court on January 17, 2023. Counsel filed the initial brief of appellant and designation in the case of State v. Kendrick Blackwell with the Court of Appeals on January 6, 2023. Counsel filed the Anders brief of appellant in the case of State v. Samuel Aaron with the Court of Appeals on December 21, 2022. Counsel filed the brief of petitioner in the case of Jarret Graddick v. State with the Court of Appeals on December 12, 2022. Counsel filed the petition for writ of certiorari to the Court of Appeals and accompanying appendix in the case of William Bruce Justice v. State with the Supreme Court and Court of Appeals on December 6, 2022. Counsel appeared before the Court of Appeals for Oral Argument in the case of Mitchell Rivers v. State on December 6, 2022.

3. This request is made in good faith, and not for purposes of delay. Counsel intends to continue to work on the cases with more than three extensions first so that the caseload will hopefully become more manageable in the near future, and less extensions will need to be requested.


