

Mr. Malik Deon White appeals his entry of a guilty plea and sentence of the Court on the charge(s) of Robbery / Attempted Armed, Or Allegedly Armed, Robbery; Mr. Malik Deon White appeals his September 12, 2022 guilty plea before the Honorable Brian M. Gibbons, Fourteenth Judicial Circuit to Robbery / Attempted Armed, Or Allegedly Armed, Robbery; Mr. Malik White appeals the December 12, 2022, sentencing before the Honorable Brooks P. Goldsmith, Fourteenth Judicial Circuit, where Mr. Malik Deon White was sentenced to a term of incarceration of 15 years; and Mr. Malik Deon White appeals the Denial of his Motion for Sentence Reconsideration before the Honorable Brooks P. Goldsmith, Fourteenth Judicial Circuit, on January 18, 2023. As grounds therefore Mr. Malik White asserts that his plea was not knowing, voluntary and intelligently made on September 12, 2022 as he lacked sufficient information of the facts and circumstances of the State's proffer. Furthermore, Mr. Malik White asserts that on December 12, 2022 the Court improperly considered facts and circumstances in sentencing of charges for which Mr. Malik White maintained a presumption of innocence.




