
INDICTMENT

At a Court of General Sessions, convened on September 16, 2021, the Grand Jurors of Beaufort County present upon their oath:

Attempted Robbery - Armed or Alleging Armed With Deadly Weapon

That in Beaufort County, South Carolina, on or about November 16, 2020, the Defendant, MALIK DEON WHITE, did commit attempted robbery while armed with a pistol, dirk, slingshot, metal knuckles, razor, or other deadly weapon, or while alleging, either by action or words, he was armed while using a representation of a deadly weapon or any object which a person present during the commission of the robbery reasonably believed to be a deadly weapon, all in violation of Section 16-11-330(B), et al. of the Codes of Law of South Carolina.
