I am writing in response to the Court's letter dated January 10, 2023, regarding ordering the transcript in this matter. I, initially, contacted the Spartanburg County Master-in-Equity Shannon Phillips' office on December 1, 2022, to inquire how to get a transcript of the WebEx hearing held September 20.
