Verdin overruled Respondents/Appellants' objection to the admissibility of Plaintiffs' Exhibit 3. Trial Tr., p. 93. By Order filed November 17, 2022, the Honorable Letitia H. Verdin denied Respondents/Appellants' motion to reconsider the decision to admit Plaintiffs' Exhibit 3.


