MOTION FOR AN EXTENSION OF TIME TO

Counsel for Reginald D'Aron Campbell, respectfully requests a **fourth and final thirty (30) day extension from February 21, 2023 until March 23, 2023**, in which to serve and file the Initial Brief of Appellant and Designation of Matter in the above-referenced case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a fourth request for an extension. In support of this request, counsel shows:

1. The Initial Brief of Appellant and Designation of Matter in this case are due to be served and filed with the Court today. The Court has granted counsel three previous extensions.
2. Counsel for appellant respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions


previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.

Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Travis Hutchinson v. State with the Supreme Court on January 27, 2023. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Robert Bunyan Hollis v. State with the Supreme Court on January 20, 2023. Counsel filed the Johnson petition for writ of certiorari and accompanying appendix in the case of Jerry Davis v. State with the Supreme Court on January 12, 2023. Counsel filed the initial brief of appellant in the case of State v Samuel McNeil with the Court of Appeals on January 6, 2023. Counsel filed the petition for rehearing in the case of State v Melvin James White with the Supreme Court on December 29, 2023.






