

1. Case caption (i.e. State v. John Doe)
2. Name of presiding judge
3. County of proceeding
4. Date(s) of proceeding
5. Court reporter name, if available (If Webex, please indicate this in the box provided)

Once you have completed the form, please return it to this office. Please note that there is no provision for court reporters to prepare and deliver transcripts at no cost to a party. Please refer to Rule 607 of the South Carolina Appellate Court Rules (SCACR), for the current fees charged to all parties for transcription services. Additionally, it is helpful to note that court reporters have sixty days to prepare a transcript once satisfactory payment arrangements have been made. They may also ask for up to four (4) 30-day extensions, if they are unable to complete the transcript by the initial deadline.
