My Name is William Morgan Jr. SCDC # 38964
I am presently incarcerated in Kershaw Correctional
Institution. I've just received your letter dated
Feb 13, 2023. and I will attempt to do as you
asked.

First let me say I have no idea of what
I am doing and in need of help. so please correct
what is wrong. Thank you.

ISSUE # 1) that my counsel did a poor job, I
was up for a bond hearing Nov 14, 2022 and I
called the Public defenders office and they were aware
of my bond reduction hearing then 2 days later Mr.
Walker came up to the jail to tell ~~me~~ me that
the state was ready to go to trial (Mind you
I was incarcerated in county jail for 26 months
and I was never afforded to be at the grand
jury and the time frame for the grand jury
was over 2 years, with no bond.)

ISSUE # 2) that I originally fired David Mathews
as my attorney and they appointed Mathew Walker
who is in the same office to my case. which
means conflict of interest dealing with the same

law firm.

Issue 3) The investigator of my case has passed away from COVID and I was never informed or brought up in front of the Judge for change of circumstances and given a bond.

Issue 4) I was never afforded the opportunity to be afforded counsel of my choice (a bond to obtain my own defense.)

Issue 5) That in the process of Matthew Walker doing the beginning of trial procedures told me that he did not feel we should go to trial because of my feet and that he felt that I could have driven 2 1/2 hours from work to molest this child. He didn't believe me.

Issue 6) That the victim was found with an STD that I did not have, and that it could of come from Virginia to Virginia.

Issue 7) That none of the time frame never matched up with my work times and that Mr. Walker did not want to go through the tapes of me being at work

issue 8) That the area that said crime was committed would be impossible during the day time (before 7pm) when I leave my job in Mount Pleasant at 8pm.

issue 9) That the 2 arriving officers lied on their report. That they body cams shows something total different.

issue 10) That both phone was confiscated and only my phone could not be downloaded because the officers (IECs) broke my phone.

issue 11) That Mr Walker agreed to a ~~20~~ 20 year sentence and told me I could get 10 or less if I agreed and that the judge is a reasonable judge, when all along he (Mr Walker) and the District Attorney already agreed to 25 years.

issue 12) That Mr Walker should never should have handled my case from the beginning. Because I fired his co-worker.

issue 13) That my past which was 35 years ago should never have been brought into this case because this was the only reason why I took the Alford's Plea

I Don't know if I've Done this the right way or the way you wanted it done. I don't know what issues Mr. Matthew Walker has brought to you because I was never informed. As I asked before please help me in this matter Thank you

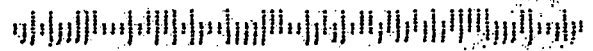
