To the Court of Appeals,

The Appellant comes before this court in “Objection” and Opposition to the Respondents “Motion to Dismiss”. The Appellant contends that the Respondents attorney is guilty of the same thing he is asking the court to hold against the Appellant.. The Respondent is claiming that there was a problem with the service of the documentation in the case but the respondent was also sited for not supplying serving the platiniff with the appropriate paperwork as well. The Appellant contends that the Respondent served upon the court specific paperwork as Proof of Service but has not delivered any paperwork to the Appellant by email or by regular US Mail.

Appellant contends that the Respondent is still refusing to defend any of the statements that were clearing made in the appeal.. The Appellant will attempt to go over the motion to dismiss and reply back to the court on the issues and explain. First the Appellant would like to bring to the courts attention that the defendnet is again using the same tacttics as he did in the other courts to try to overshadow the complaint with litigation and the complaint is never resolved or hear.. The Respondent in this case is trying to stop the court from seeing that his client is guilty of “Credit Card Fraud” and is doing everything to prevent the court from seeing the letter written to the city to make Mr. Adams home a Group Home and leave Mr. Adams with no where to stay. Appellant fcontends that theh Respondent was served with all the paperwork that is now at the court house on file but has since made additional copies of the paperwork as well as copies of the official transcript as it was delivered by the probate court unaltered.

I.

Respondent Betty Ogbuneke, through her attorney, hereby moves to dismiss the Appellant’s Complaint pursuant to South Carolina Rules of Civil Procedure (SCRCP) Rule 260(a) as Appellant has failed to comply with the requirements of the Rules and in the alternative, a Motion for a Dismissal under 12(b)(6) for failure to state a claim under S.C. Code Ann. § 62-1-308(I). Respondent further requests for attorney fees of \$2,500.00 and costs pursuant to South Carolina Court Rule 222.

Appellant Objects:

1. Appellant contends that the Respondent is asking the court for 2500.00 when Mrs. Ogbuneke has not paid any part of the taxes for the last 4 years.
2. Appellant contends that for the last 18 years the Respondent has not contributed anything to the upkeep of the estate and has paid no taxes at all but is asking for lawyer fees.
3. Appellant contends that he paid the taxes for 2022 this year and for the last 4 years as well while Mr. Joe L. Adams Sr. was transitioning and during year of the hearings as well as the through the appeals in this court and Mrs. Betty Ogbuneke and her lawyer have ignored any responsibility of the estate.. Please see EXHIBIT I.
4. Appellant contends that the Respondent is guilty of Credit Card Fraud of which documentation is submitted and is available online at the Circuit Court of York County and more credit card fraudulent activity has been recently discovered.

II.

MOTION TO DISMISS
(Failing to Preserve Issues for this Appeal)

Appellant appealed an Order from Probate Court pursuant to South Carolina Code Ann. §62-1-308(b) to the Circuit Court. At the Circuit Court, Appellant failed provide a statement of the issues on appeal and failed to raise an issue of law on his first appeal; he now seeks to raise the issues here.

Appellant Objects

1. Through the review of the Transcripts there is evidence that proves that the Appellant did present the issues on appeal and it is evident through the transcripts that were prepared by the Transcripts Department of the Circuit Court of South Carolina and cost 85.00.
 - a. Appellant contends that the transcripts will prove that the issues were raised during appeal and because the judge was not fully prepared for court, he had not reviewed the documentation and had to be presented with the copies of the documents during open court.
 - b. Appellant contends that he offered the Judge the transcripts and the judge did not acknowledge but ask the Appellant if could show where the court was in error then he would give him one shot.. the

Appellant stated in open court that he never got a chance to testify on his own behalf or show any of his evidence. But Judge McKinnon decided to go along with the other judge and not conduct any finding of facts for the case which cause the error of the Probate Court to be inherited into the Circuit Court of Appeals.

2. Through the transcripts the court will be able to see clearly the unethical activities of Mr. Cyrus Corbit as well as the problems with the Probate Court Hearing that caused a spiral effect of injustice and prejudice to the Appellant.
3. Appellant contends that in his Informal Brief he did state the issues on appeal and has also made a motion to amend the Informal Brief.

III.

A statement of the issues presented for review. The statement shall be concise and direct as to each issue and may be stated in question form. Broad general statements may be disregarded by the appellate court. Ordinarily, no point will be considered which is not set forth in the statement of the issues on appeal.
South Carolina Court Rule 208(b)(1)(B)

Appellant Objects

1. Appellant contends that there are many issues on appeal that are detailed in the Informal Brief.
2. Appellant contends that the statement are clear to what the Appellants issues were and were identified as the form guide from the Appeals court presented.

IV.

Appellant has failed to comply with the requirements of Rule 208(b)(1)(B) on his first appeal and failed to provide a verbal answer as to an issue of law to Judge McKinnon at the hearing for his first appeal. Therefore, the first appeal was dismissed. Appellant's Brief focuses on the idea that he is receiving a second bite of the proverbial apple, which is not a standard for appeal.

Appellant Objects:

1. Appellant did present to Judge McKinnon the issue of law that he did not get a chance to testify on his own behalf or show any of his evidence during the Probate Hearing..
2. Appellants statements are outlined in the Transcripts prepared by the court system and detail every word that the Appellant and Respondent stated..

3. Appellant contends that to see the false testimony from Mr. Corbett to the court the court will need to review the original Transcripts from the Probate Court that:
 - a. Appellant never was allowed a chance to present the evidence that was brought to court during the hearing
 - b. Appellant never got a chance to do anything but ask questions as judge Woodruff stated that the Appellant during the beginning of the hearing could only ask question and to hold on that she would allow the Appellant a chance to testify at the later in the hearing..
 - i. Appellant contends that shortly after that Judge Woodruff can be heard stating that she had to go because the Bailiff was on overtime.
 - ii. Appellant contends that these statements are outlined in the transcript documentation of the Probate Hearing with Judge Woodruff at the Probate Court in York South Carolina prior to the Appeals hearing.
 - iii. Appellant contends that the reason the appeal was submitted is because the judge was unfair in ruling from the Bench as the rule of civil procedures dictated that all evidence and testimonies should be heard before ruling from the bench.
 - iv. Appellant contends that this caused a Great Prejudice and Suppression of Critical evidence as the Appellant is the “Interested Party” in the case due to the financial investment.
 1. Appellant contends that when the application was filed by the Respondent that the application was purposely falsified and reflected that there was no ‘Interested Party’ but during that time many other parts of the application were falsified as pointed out in open court by Judge Woodruff as reflected by the transcripts that she sent to the Appellant from the Probate Court.

V.

MOTION TO DISMISS PURSUANT TO

(12)(B)(6) For Failure to State a Claim According to South Carolina Code Ann. § 62-1-308(I)

Pursuant to S.C. Code Ann. §62-1-308(I), “The circuit court, court of appeals or Supreme Court **shall** hear and determine the appeal according to the rules of law. The hearing must be strictly on appeal and no new evidence may be presented.” (Emphasis Added). The Appellant seeks to have the appeal consider evidence that he was unable to submit at the hearing. This evidence in the form of exhibits and statements in his appeal. Neither the exhibits nor the transcripts were served on the Respondent for review. Further, the Appellant fails to state an issue of law for this court to consider and for that, his appeal should be dismissed.

Appellant Objects:

1. Appellant contends that all the documents were served upon the Respondent in the onset of the first appeal to the circuit court as they were part of the Probate Hearing.
 - a. Appellant contends that he served the Respondent with a Thumb Drive of all the evidence as well as submitted it to the Circuit Court Clerk for filing into the case as evidence.
 - b. Appellant contends that if the appeals court were to review the court video that the appeals court will see that the Appellant had all the evidence at the court but was never given any time to present the evidence even during the Appellant testimony.
 - c. Appellant contends that there was no opportunity to say anything to support his position as the Interested party.
2. Appellant contends that no new evidence is being presented and ask that the court will review the dates of the submission of evidence and documentation that were submitted after service to Mr. Corbett in Chester South Carolina.
3. Appellant contends that he recorded the service to prove that he served the Thumb Drive that contained all the evidence referred to in the Informal Brief but it is also online at the Circuit Court Website in York South Carolina under the Circuit Court Case Number..

- a. Appellant contends that he had all the evidence to submit to the court as Evelyn Rodas (case manager from probate court) instructed the Appellant to bring his evidence to court and that it could not be submitted to the court prior to the hearing.
 - b. Appellant contends that the letter from the probate court instructs the parties to bring the evidence to court but in the Appellant's case the judge ruled from the Bench before she could hear any testimony or complete any Finding of Fact in the case.
4. Appellant ask that the court review EXHIBIT I "York County Sixteenth Judicial Circuit Public Index" to see all the documentation that has been submitted as all the documents were served on the Respondent as well as preserved in the Court System in York South Carolina.
 5. All Exhibits are included in the filings. Nothing was presented new to the court but Judge McKinnon did not take time to review the evidence prior to the hearing.

VI.

WHEREFORE, Respondent Betty Ogbuneke moves this court for an Order dismissing this Appeal in its entirety with prejudice including attorney fees of \$2,500.00 pursuant to Rule 222. This Motion is based on the SCRPC, statutory and case law as well as the Complaint that was submitted before the court. Due to the adversarial nature of this Motion, Counsel certifies that there is no duty to consult with the Appellant prior to filing this motion under Rule 11(a) SCRPC.

Appellant Objects:

1. Appellant contends that Mrs. Ogbuneke has not provided any proof of anything and her attorney has been able to manipulate the service of documentation and submit the documents to the court.
2. Appellant contends that the Mr Cyrus Corbett has been standing in between him and his sister and has instructed the Appellant not to speak to his sister..
3. Appellant contends that during the hearing Mr. Corbett can be heard coercing the respondent and making sure his services would always be needed.
4. Appellant contends that Mr. Cyrus Corbett made false testimonies to the Circuit Court and is still performing unethically in this appeal effort.
 - a. Appellant contends that Mr. Corbett contacted the court on January 26, 2023 and submitted a "Motion to Dismiss".

- b. Appellant contends that Mr. Corbett stated in the Proof of Service that he served the Appellant through Email and Regular Mail but he **did not**.
 - i. Appellant contends that the submission to the court was not done in the format that the court instructed the Appellant to do which was to copy everyone involved in the case on the documents submitted to the Court of Appeals through the email.
 - ii. Appellant contends that he has consistently submitted to all documents to the court with Mr. Corbett CC: on the submissions.
 - c. Appellant contends that the Appeals court issued the Deficiency on January 30, 2023 and the Respondents attorney actually did not mail the hard copy according to the tracking information until January 30, 2023 not January 26, 2023 as the documentation that was presented to the Appeals Court in this motion states.
 - d. Appellant contends that the Certified letter was never delivered but was misdelivered to his home on February 8, 2022.
 - i. Appellant had called to the Court of Appeals after receiving the deficiency letter to see what submission was made that he was not copied on.
 - ii. Appellant called again and spoke with the Court Clerk who informed him that the deficiency letter was sent because of the problem with service.
 - e. Appellant contends that the information from the tracking number proves that the respondents attorney has been manipulating the court as he did during the Circuit Court Appeals Hearing..
 - i. Appellant contends that Mr. Corbett had his process servers to bring letters to his home and put them in the fence outside the house more than 75 ft from the front porch facing the road..
 - ii. Appellant contends that he was never served during that time because the same process server can be seen on the security camera footage coming back and removing the paperwork before the Appellant could get home to receive it.
 - iii. Appellant contends that because of the problems with the mailing that the service was never completed and the dates were misrepresented to the courts on purpose to cause the Appellant not be get the paperwork in time to respond.
5. Appellant contends that the Respondents attorney signed the “Motion to Dismiss” for January 1, 2023 which is also an inaccurate date on the appeal paperwork page.
- a. Appellant contends that since the document is signed for **January 1, 2023** that the Appellant had not submitted the “Informal Brief” so there is no way that the Appellant should be held accountable for a document signed more than 25 days before it was submitted to the court.

- b. Appellant contends that the “Motion to Dismiss” must have been written prior to receiving the Appellants “Informal Brief” which explains why the Respondent has failed to respond to any of the important issues brought in the “Informal Brief”.

Appellant Objects:

1. Appellant submits to the court proof that the documentation was not mailed until after receiving the letter of Deficiency from the Appeals Court on the 30th.
2. Appellant contends that there has been no electronic copies sent and there was no attachment to the original submission to the appeals court.
3. Appellant contends that Mr. Corbett has been more open to conversations to other attorneys that he assumed were on the case than he is to the Appellant as he has ignored every single attempt at making some type of communication between the Respondent and the Appellant.
4. Appellant needed help with the taxes and other expenses and wanted to just have a chance to speak during the time our father’s birthday and Father’s Day but nothing.
5. Appellant contends that in this closing statement the court can see there is a problem with the dates and the statement of the electronic mail that was never sent.

6. Appellant contends that "Motion to Dismiss" was submitted to the court on January 26, 2023 but the Service to the Appellant date is January 30, 2023 but according to the USPS the package was not delivered as of February 4, 2023 and was not received until February 8, 2023.

In conclusion

Appellant ask that the court will not dismiss his claim and will give the claim a fair review. Appellant ask that if the court finds that there are deficiencies on the Appellants part that the Appellant will be given a chance to correct the problems. Appellant has had a hard time with the Respondent refusing to help with estate financial help as the taxes were paid again this year and for the last 4 years by the Appellant and the only reason the Respondent has ever offered any help but ask for money to pay attorneys and has not offered any refund for the thousands of dollars that have been paid by the Appellant.
