Breach of trust with fraudulent intent, value more than \$2,000 but less than \$10,000

At a Court of General Sessions, convened on August 1, 2019 the Grand Jurors of SUMTER County present upon their oath:

COUNT ONE: BREACH OF TRUST

That Celia Elizabeth Windham did in Sumter County on or about November 8, 2018, having been entrusted by the owner of Michael McCoy with the care, keeping, and possession of a car valued at more than one thousand (\$2,000.00) dollars, but less than ten thousand (\$10,000.00) dollars, did feloniously convert and appropriate such property to his/her own use and purposes, with intent to deprive the owner thereof, in violation of Section 16-13-0230(B)(2), S. C. Code of Laws, 1976, as amended.

Against the peace and dignity of the State, and contrary to the statute in such case made and provided.
