**RESPONDENT WENDY LYNCH'S MOTION FOR EXTENSION OF TIME TO FILE
RESPONDENT'S INITIAL BRIEF AND DESIGNATION OF MATTER TO BE INCLUDED IN THE
RECORD ON APPEAL**

Pursuant to Rule 240, SCACR, Respondent Wendy Lynch hereby requests a thirty (30) day extension of time to file Respondent's Initial Brief and Designation of Matter to be Included in the Record on Appeal.

Appellant's Initial Brief and Designation of Matter to be Included in the Record on Appeal was filed on February 3, 2023. Pursuant to Rule 208, SCACR, Respondent's deadline for her Initial Brief and Designation of Matter to be Included in the Record on Appeal is therefore March 6, 2023. Respondent submits that good cause exists for this extension. The trial in this case spanned a five-day period and additional time is needed to adequately summarize the evidence from the multi-volume trial transcript.
