

lent practices, effectively immediately! Please note that this case is to continue until justice is rendered for the Plaintiff (class action persons). Continuance of case findings is requested.

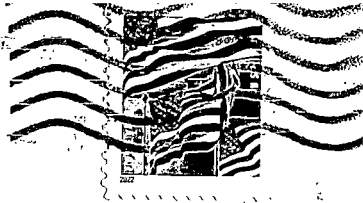
