Motion to Deny the Motion to Strike the Designation of Matter

The Designation of matter clearly states that I am requesting an overturned for the decision made to deny my benefits. All of the information provided is on record already, the pages included is from the initial hearing. I did not include subheadings, because I am not an attorney and it was not a requirement when I submitted my Designation of Matter.

In addition to, I have written several Appeals to SC DEW and SC Administrative Law Court, neither party has never had an issue with the way my appeals were written or my responses to them. This is the first time they have asked me to rewrite or redo a response to them and it has been 2 years.

The Designation of Matter I wrote includes facts and evidence that supports why my benefits should not have been denied and the pages included are from the hearing and documents I received from the parties denying my benefits, so all parties involve has these documents. None of the evidence submitted is new, SC DEW has these documents on record.

The approved LOA with my correct returned to work date was submitted before the hearing on September 1, 2021. Proof of the demotion and accusations of me missing days from work avoiding my manager and being a no call no show was submitted with the initial appeal to SCDEW. If someone listens to the hearing that transpire on September 1, 2021, all of these issues were discussed. Why am I not allowed to provide proof that Tran and McCrea lied during the hearing and my benefits should not have been denied? The request SCDEW is making to strike my Designation of Matter is unfair and would remove pertinent evidence that is needed to resolve this matter.

I am a regular Citizen, not an attorney and the expectation SCDEW is placing on me is unfair based on the knowledge I have with writing a Designation of Matter. SCDEW is abusing their power and my rights as a citizen to request a strike on the way I wrote my Designation of Matter, because I did not use legal terms. I did not go to law school or have a license to practice law and use legal terms. My response is based on my educational background and knowledge that I have as a citizen with rights to appeal the decision that was made on behalf of my benefits that I have worked hard for, 7 years to be exact.
