Counsel filed the *Anders* Brief of Appellant and the Record on Appeal in the case of the State v. Bobby Ray McClure, Jr. with the Court of Appeals on January 30, 2023. Counsel filed the Reply to Return to Petition for Writ of Certiorari Pursuant to Mack v. State in the case of John Willie Mack, Sr. v. The State with the Court of Appeals on January 13, 2023.


4. Counsel makes this request in good faith and not for purpose of delay.

Deputy Attorney General Donald J. Zelenka for all Appellate Defense extensions through March 31, 2023.


