REASON FOR ME WRITING YOU BACK TO INFORM  
YOU THAT I JUST RECEIVED THE APPEAL NOTICE  
THE REASON FOR MY APPEAL FOR THE CHARGE  
OF 2023-GS-00880-DOMESTIC VIOLENCE 2ND  
DEGREE. MR HONORABLE JUDGE T.W COOPER  
ON JANUARY 31, 2023 GAVE ME 3 YEARS  
SENTENCE TO 2 YEARS FOLLOWED BY 18 MONTHS  
PROBATION. AT THAT TIME OF ME BEING  
SENTENCE I WAS UNDER MEDICATION FOR  
MENTAL HEALTH SERVICE FOR MY ILLNESS THAT  
BEING DIAGNOSED WITH MDD, PTSD WITH A LONG  
HISTORY OF SCHIZOPHRENIA. UPON TAKING THE  
PLEA DEAL I WASN'T AWARE OF ME PLEADING  
TO 3 YEARS WITH PROBATION OF 18 MONTHS. I  
WAS NOT CLEAR ON UNDERSTANDING THAT OPEN  
DEAL IN FRONT OF JUDGE COOPER T.W. I THOUGHT  
I WAS PLEADING TO A SET PLEA WHICH I OFFERED  
A DEAL OF 0-3 DOMESTIC VIOLENCE 2ND DEGREE  
WITH A 1 YEAR SENTENCE TO THE DEPARTMENT  
OF CORRECTION. WHICH MY D.A MRS. MELANIE-

LEARN FROM THE OFFICE OF THE SOLICITOR (2)  
SHOULD HAVE UNDERSTOOD, WHICH MY LAWYER  
DID SPEAK WITH CONCERNING THIS DEAL.

THE DEAL WAS SET FOR THAT PLEA OF THE  
1 YEAR WHICH I DID NOT UNDERSTAND I WAS  
SIGNING A OPEN PLEA WHICH WAS 3 YEARS  
AND 18 MONTHS PROBATION. I DID NOT UNDER-  
STAND WHAT I WAS SIGNING, AND WISH TO  
COME TO THE APPEAL COURT OF THE CDV 2ND  
WITH THE 1 YEAR ONLY, AT THE DEPARTMENT  
OF CORRECTIONS, AND NOT THE 3 YEARS WITH  
18 MONTHS PROBATION. WITH SPECIAL CONDITIONS  
OF CDV TASKS, AND MENTAL HEALTH -  
COUNSELING. THAT I AM ALREADY MENTAL HEALTH  
WHICH I AM ALREADY TO CONTACT MY AREA MENTAL  
HEALTH DOCTOR, AND COUNSEL FOR THESE  
SPECIAL CONDITIONS. WITHOUT HAVING TO HAVE  
A ORDER FROM THE COURTS ALONG WITH MY  
SENTENCE. MY ILLNESS PLAY A PART IN ME  
HAVING TO UNDERSTAND SOME THINGS IN ORDER  
TO BE CLEAR. I WAS RELIEVED FROM RICHLAND  
SPRINGS HOSPITAL. UNDER THE CARE OF MY  
PHYSICIAN DR FORD MURPHY D1214 AND DIAGN-  
OSIS WITH THESE MENTAL HEALTH PROBLEMS

I WAS REAR RELEASED, AFTER TREATMENT AND MAJOR TESTS WAS DISMISSED AND UPON RELEASE WAS ORDERED FROM THE STATE OF SOUTH CAROLINA COUNTY OF RICHLAND EX PARTE: DEBORAH COCK IN THE PROBATE COURT CASE # 2022 MH 1934 TO ORDER OF DISMISSAL AND VERBAL DISCHARGE AND I HAVE THIS ORDER ON HAND THE PROBATE JUDGE AMY W. McCulloch ON SEPTEMBER 6TH 2022 WAS RELEASED FROM THE RICHLAND SPRINGS. A MENTAL HEALTH JUDGE. I HAD NO UNDERSTANDING OF THE COURT OF JUDGE T.W. 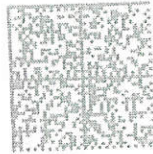
