
MOTION TO ALLOW LATE REQUEST FOR TRANSCRIPT





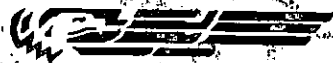
